

# ***THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE***



**BY-LAW NO. 2011-05**

**BEING A BY-LAW TO SET THE  
REMUNERATION TO BE PAID TO THE  
MAYOR AND MEMBERS OF COUNCIL AND  
TO RESCIND BY-LAW 2009-13 BEING A  
BY-LAW TO SET THE REMUNERATION TO  
BE PAID TO THE MAYOR AND MEMBERS  
OF COUNCIL.**

**WHEREAS** Sections 8 and 9 of the Municipal Act, 2001 confers authority on Municipalities to govern their affairs as they consider appropriate;

**AND WHEREAS** Section 5 of the said Act authorizes Councils to exercise the powers of the Municipality by By-Law;

**AND WHEREAS** Section 283 of the Municipal Act, 2001 authorizes Municipalities to pay remuneration and expenses of the members of any local board of the Municipality and to the officers and employees of the local board if the expenses are of those persons in their capacity as members, officers or employees, and if the expense are actual incurred or the expenses are a reasonable estimate, in the opinion of the Council or local board, of the actual expenses that would be incurred;

**NOW THEREFORE** the Council of the Corporation of the Township of Pickle Lake **ENACTS AS FOLLOWS:**

1. The Mayor shall receive an honorarium for attendance at meetings as follows:

Regular Meetings of Council	- \$180.00 per meeting
Year End Disbursement Meeting	- \$180.00 per meeting
Special Meeting of Council	- \$180.00 per meeting
Committee Meetings	- \$50.00 per meeting
In Lieu of Meals & Per Diem (Within Kenora and Thunder Bay Districts)	- \$65.00 per day meals - \$150.00 per day per diem
In Lieu of Meals & Per Diem (Outside of Kenora and Thunder Bay Districts)	- \$100.00 per day meals - \$150.00 per day per diem

2. The members of Council shall receive an honorarium for attendance at meetings as follows:

Regular Meetings of Council	- \$160.00 per meeting
Year End Disbursement Meeting	- \$160.00 per meeting
Special Meetings of Council	- \$160.00 per meeting
Committee Meetings	- \$50.00 per meeting
In Lieu of Meals & Per Diem (Within Kenora and Thunder Bay Districts)	- \$65.00 per day meals - \$150.00 per day per diem
In Lieu of Meals & Per Diem (Outside of Kenora and Thunder Bay Districts)	- \$100.00 per day meals - \$150.00 per day per diem

3. The members of Township Staff shall receive an honorarium at meetings as follows:

Special Meetings of Council	- \$160.00 per meeting
In Lieu of Meals & Per Diem (Within Kenora and Thunder Bay Districts)	- \$65.00 per day
In Lieu of Meals & Per Diem (Outside of Kenora and Thunder Bay Districts)	- \$100.00 per day

4. In the event that a meeting is cancelled for lack of quorum, the members in attendance shall be paid for the meeting.
5. Accommodation: private (per night) \$50.00.
6. Representatives to Kenora District Services Board (KDSB) or Patricia Area Community Endeavours (PACE) (if Council Member) shall be reimbursed directly by KDSB and PACE accordingly.
7. Completion of a Request for Reimbursement of Travel Expenses form (Attached as Schedule I) must be completed before remuneration will be paid out.
8. **THAT** this By-Law hereby rescinds By-Law 2009-13.
9. **THAT** this By-Law shall come into force and take effect upon the date of final passing thereof.

BE READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS
