## **BY-LAW NO. 2014-16**

BEING A BY-LAW TO APPOINT A MUNICIPAL BY-LAW ENFORCEMENT OFFICER FOR THE PURPOSE OF ANIMAL CONTROL AND ENFORCEMENT OF BY-LAW 2012-18, BEING A BY-LAW FOR LICENSING OF DOGS, PROHIBITING THE RUNNING AT LARGE OF DOGS, AND FOR REGULATING OTHER MATTERS RELATED TO DOGS.

WHEREAS under Section 9 of the Municipal Act 2001, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**AND WHEREAS** Section 10 (2), 7 of the Municipal Act 2001, as amended, authorizes a single-tier Municipality to pass a by-law for services or things that the municipality considers necessary or desirable for the public;

**AND WHEREAS** Section 15 of the Police Services Act, R.S.O. 1990, Chapter 15 authorizes Council to pass by-laws for the appointing of Municipal Law Enforcement Officers;

**NOW THEREFORE** the Council of the Corporation of the Township of Pickle Lake *ENACTS AS FOLLOWS:* 

- 1. **THAT** James Brown is hereby appointed By-Law Enforcement Officer for the purpose of enforcing the By-laws of the Corporation of the Township of Pickle Lake regulating animals and animal owners.
- 2. **THAT** Eric Brazeau is hereby appointed By-Law Enforcement Officer and may act in the absence of James Brown for the purpose of enforcing the By-laws of the Corporation of the Township of Pickle Lake regulating animals and animal owners.
- 3. **THAT** all by-laws not consistent with this by-law are hereby repealed and rescinded.

**THAT** this By-law shall come into force upon the date of signing.
