BEING A BY-LAW TO ENTER INTO A WATER TREATMENT, WASTEWATER TREATMENT, WATER DISTRIBUTION AND WASTEWATER COLLECTION SYSTEM – OVERALL RESPONSIBLE OPERATOR SERVICES AGREEMENT WITH NORTHERN WATERWORKS INC.

WHEREAS under Section 9 of the Municipal Act 2001, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS Section 10 (2), 4 authorizes a single-tier Municipality to pass a by-law for public assets of the municipality acquired for the purpose of exercising its authority under this or any other act; and section 10(2) 6 for the health, safety and well-being of persons;


AND WHEREAS the Council of the Corporation of the Township of Pickle Lake wishes to enter into a Water Treatment, Wastewater Treatment, Water Distribution and Wastewater Collection System – Overall Responsible Operator Services Agreement with Northern Waterworks Inc.;

NOW THEREFORE the Council of the Corporation of the Township of Pickle Lake **ENACTS AS FOLLOWS:**


1. **THAT** the Mayor and Clerk-Treasurer are hereby authorized and directed to sign on behalf of the Corporation to enter into an agreement.
