AND WHEREAS the Corporation of The Township of Pickle Lake wishes to designate financial signing authority;

AND FURTHER WHEREAS there shall be two (2) signatures on all Municipal financial documents and commercial bank accounts; one (1) being a Council Member and one (1) being an administrative designate:

NOW THEREFORE the Council of the Corporation of the Township of Pickle Lake **ENACTS AS FOLLOWS:**

1. **THAT** the Head of Council (Mayor Karl Hopf) and the Councillors named below shall be designated as having signing authority for the Council;

 - (c) Councillor William Mackechnie
 - (d) Councillor Jeremy Millar
2. **THAT** the Temporary Deputy Clerk-Treasurer (Leona McColeman) shall be designated as having the signing authority for the administration;
3. **THAT** all previous by-laws inconsistent with the foregoing are hereby repealed.
4. **THAT** this By-Law shall come into force at the time of passing.

AND WHEREAS Section 77(2) of The Municipal Act, R.S.O. 1990 as amended, provides that the Council may appoint a deputy treasurer who shall have all the powers and duties of the treasurer under this and every other Act;


WHEREAS the Council of the Corporation of the Township of Pickle Lake deems it advisable to appoint a Deputy Clerk-Treasurer;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE ENACTS AS FOLLOWS:



BY-LAW NO. 2016-09

BEING A BY-LAW TO ENTER INTO AN AGREEMENT BETWEEN NORTHERN ONTARIO HERITAGE FUND CORPORATION "NOHFC" AND THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE

WHEREAS under Section 9 of the Municipal Act 2001, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS Section 10 (2), 7 authorizes a single-tier Municipality to pass a by-law for services or things that the municipality considers necessary or desirable for the public;

AND WHEREAS the Council of the Corporation of the Township of Pickle Lake wishes to enter into an Agreement with Northern Ontario Heritage Fund Corporation "NOHFC";

NOW THEREFORE the Council of the Corporation of the Township of Pickle Lake **ENACTS AS FOLLOWS:**

1. **THAT** the Clerk-Treasurer is hereby authorized and directed to sign on behalf of the Corporation to enter into the agreement.
2. **THAT** the Agreement attached to this By-Law as Schedule "A" is part of this By-law.
3. **THAT** all by-laws not consistent with this by-law are hereby repealed and rescinded.
4. **THAT** this By-law shall come into force and take effect on the date of final passage thereof.
