## **BEING A BY-LAW TO APPOINT A TEMPORARY DEPUTY CLERK-TREASURER FOR THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE**

**WHEREAS** Section 73(2) of The Municipal Act, R.S.O. 1990 as amended, provides that the Council may appoint a deputy clerk who shall have all the powers and duties of the clerk under this and every other Act;

**AND WHEREAS** Section 77(2) of The Municipal Act, R.S.O. 1990 as amended, provides that the Council may appoint a deputy treasurer who shall have all the powers and duties of the treasurer under this and every other Act;

**WHEREAS** the Council of the Corporation of the Township of Pickle Lake deems it advisable to appoint a Deputy Clerk-Treasurer;

**NOW THEREFORE**, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE ENACTS AS FOLLOWS:

1. THAT Jamie Thiessen be appointed Temporary Deputy Clerk-Treasurer
2. AND THAT this By-Law shall come into force and take effect upon the date of final reading and passing thereof.


**NOW THEREFORE** the Council of the Corporation of the Township of Pickle Lake **ENACTS AS FOLLOWS:**


