- Attended KDSB Meeting, Municipality requested to support application in cooperation with the Keewatin Patricia District School Board for housing grant application;
- 2018 KDSB budget approved with 35 per cent overall increase, requiring 1.9 per cent hike in local support, reflecting 0.85 per cent increase for municipalities and significantly higher rate increase for the unorganized territories served by KDSB. Pickle Lake's total requisition for 2018 will be \$52,787
- Discussed the new Ambulance Base for Pickle Lake building will be approximately 6,800-square feet and will include lodging for EMTs. Purchase offer to be received in near future for land.
- Wrote letter to NAN Legal Services to follow-up Nov. 29 meeting where the Ice Road Traffic was discussed. Follow-up with law enforcement determined vehicles driving on the NORT Road fall under Highway Traffic Act legislation.
