### 5. DELEGATIONS

Sgt. Kevin Thomson from OPP introduced himself to Council. He is acting as the Sgt. in Pickle Lake for a temporary 3 month posting. He has 10 years experience as a constable. Sgt. Thomson stated there will be 2 new recruits coming in February as there are several officers leaving this year and another 1 possibly in May. Councillor Millar, Mayor Monck and Councillor Blakney commented on the need to keep the officers in our community active in pick ups of local intoxicated persons as this issue has not been taking as much attention as it has in previous years, seeing as the amount of arrests has gone down. They stressed the fact this is a community safety issue both for the intoxicated individuals as it could lead to misadventure as well as for individuals driving etc. The Sgt stated he will continue to work within the statues of the law and ensure the officers are performing their duties within these realms. The private OPP road was discussed as well, and Council asked that the officers be reminded that they should not be accessing the detachment via Trudel Dr. as there is not to be travelling traffic by the school for safety reasons. The Sgt. stated he would reiterate this in an email to his team.
