6.1. Mayor and Council

6.1.1 Councillor Blakney- Shared information about the symposiums at KDMA. This year's theme was go Green, lots of information shared about Solar and Wind power and ideas brought back to Pickle Lake on going green initiatives.

-KDMA is to be hosted in Pickle Lake 2020- discussions are being had with KDMA about moving the event to the summer. If feasible, Old Post lodge will be rented out for the event, with conference being held at the community hall and local businesses providing catering. A market will be hosted at the arena to show case local businesses. A theme must be developed for the conference also, discussion about entrepreneurial initiatives being the theme was had.

-March Council meeting to be held at the community hall, show case some local fire safety prevention, team up with the fire department on this public education. Provide some further information on community development projects.

- 6.1.2. Councillor Millar- Had a query from a local rate payer regarding a new house in Central Patricia. Clerk stated proper channels were being gone through building department.
- 6.1.3 Councillor Vaughan- commented on feasibility to work with Moncreif regarding clearing- perhaps skid some trees to the landfill for people to access the wood.
- 6.1.4 Mayor Monck- Brought attention to correspondence received in the afternoon regarding NWHU Levy increases from both Sioux Lookout and Dryden.
- -ROMA conference was good, Mayor Monck approached Minister of Natural Resources regarding transferring all the property within the municipal boundaries to the municipality or the province should start paying taxes on it. All municipalities in the Northwest are landlock within their municipal boundaries for development.
 - -Court will be going to Mishkeegogamang officially starting April 1st.
- -Mayor would like Terry to talk to Public Works in Mish regarding a cost to compact our garbage.
- -New flag at fire hall needs to be installed. Clerk to contact MP's office for some new flags and also invite MP Meilillo to visit Pickle Lake.
- -Resolution for next council meeting voicing support for Ignace's endeavour to house nuclear waste. Will bring 7500 jobs to Ignace, huge economic development opportunity for them. Invite Ignace to the tradeshow in March for promotion/education.
- -Clerk asked is Council could provide a bursary for the school to a graduating student. Council is in favour of this. Will discuss further.

-All is running smoothly with cemetery board, some beautification will take place at the cemetery this spring, shrubbery and concrete walking path around the columbarium.

-Mayor asked Superintendent if we could have the lights unplugged at the corner, also requested come up with a pole design and a more straight edged tree for next year.
