- -Sigfusson/Valard crew changes utilizing own aircraft, potentially using Webenville vs Pickle Lake stop through, conferring with Wasaya for utilizing airstrip.

3.3 Clinic Nurse Betty Johnson

- -Face shields have arrived.
- -Awaiting a few more back ordered items.
- -Current stock of PPE ok but looking to improve stock numbers.
- -Some updates on symptoms released include: fatigue, running nose, loss of smell, cold like symptoms. Ensuring phone screening taking place prior to consults in Clinic.

3.4 Pickle Lake Fire Rescue Chief Garrick Halteman

- Duty to respond to calls still active
- -Practices still suspended, Deputy Chief Koval and Captain Dalzell working on distance education for firefighters.
- -Water still an issue at hall however PPE and bucketed hand washing measures set up.
- -PPE numbers submitted weekly to Larry Lundy for Provincial tracking.

3.5 Superintendent Terry Zapf

- -PPE in good supply
- -Hand sanitizer arrived from Thunder Bay Broom and Chemical.
- -Awaiting order of disposable coveralls.
- -Barricades/Signage remain in place at campgrounds/playgrounds.

- -Social Distancing continues
- Buildings remain closed.
- -Updates on website for funding for businesses/individuals
- -15 vests donated to checkpoint in Mishkeegogamang
- -245 Municipal Declarations/63 FN's.
- -Any potential Hwy disruption will be communicated by OPP directly to Municipality and from there to EMS/Fire/MNRF
- -Staff continuing sanitization and safety measures.

3.7 OPP- SGT. Kevin Thomson

- Check point in Mish enacted Saturday April 18th at 12:00 p.m. CST.
- -Appropriate signage and lighting in place supplied by MTO. Well thought out over passed 3 weeks, no rushed decisions in process, making sure community is safe, workers are safe, and everyone is informed and educated.
- -Warm up shelter, generator and heater as well as 2-way radio communications. A cell booster has been recommended.
- -Jim Davis from Atikoken will be working 4:4 split with Kevin Thomson. Both will do best to provide daily updates on checkpoint.
- -Concerns regarding immune suppressant travelers have been addressed, will talk to chief Masakeyash to see if there is a way to streamline these travelers, ie. Call in advance of travel, show a sign, and crack the window only to maintain social distancing when talking to checkpoint staff to avoid rolling window down. Checkpoint staff maintaining safe distance for themselves and travelers
- -No further update from Chief Masakeyash on road closure.
- -First week of May 3 recruits coming to Pickle Lake.

3.8 MNRF Steve Anderson

- -12 individuals came in over weekend. Prescreened and social distanced interview with Steve.
- -4 crews on staff to assist with fires.
- -will be training crew for Mish to assist local Mish department with fire protections. Trying to keep crews separated so no crossing between communities crews.
- -Secured additional properties in Pickle Lake to maintain socially distanced living accommodations.
- -Absolutely zero tolerance for any inappropriate behavior, gatherings over permitted provincial standard. Report any activities to Steve immediately.
- -All Rec facilities are closed.

Sgt Thomson thanked everyone for their patience and hard work that goes into this planning. Working together is what continues to make this a successful process. Clerk thanked Council for their guidance and leadership as Pickle has not had an easy year in 2019 and now we are facing COVID. Comments were acknowledged by parties on line.

No further comments or concerns at this time. Next meeting will occur at 17:00 on Monday April 27th, 2020. All parties are asked to call into the meeting if they currently do not work daily in the Municipal Office to continue with social distancing measure.

- -30 staff in different processes of training, maintaining social distancing.

- School Closure extended.
- -Inquired if we can plan a space or building for quarantining a family/individual if necessary.
- -Community Hall recommended, Councilor Millar recommended coordination with Mishkeegogamang on this and potentially one of their ATCO trailers if needed. Clerk to obtain resources for this planning from Julia and touch base with Pandemic coordinator in Mish.
- 3.7 Superintendent Terry Zapf
- PPE in good supply.
- -Will check all closure notices to ensure still in place.
- 3.8 Clerk Treasurer Jamie Hussey
- 247 Municipal Declarations, 70 FN.
- -Province rolled out reopening plan diagram today, shared via email.
- -Closures extended until May 12th. Municipality to follow suit.
- -Community Garden/Greenhouse will open when ready and proper signage has been posted.
