- -PPE in good supply

3.3 Pickle Lake Fire Rescue Chief Garrick Halteman

- Duty to respond to calls still active
- -Practices still suspended, Deputy Chief Koval and Captain Dalzell working on distance education for firefighters.
- -Water still an issue at hall however PPE and bucketed hand washing measures set up.
- -PPE numbers submitted weekly to Larry Lundy for Provincial tracking-Garmen Inreach to be purchased at FD's discretion.

3.4 MNRF Steve Anderson

- -4 crews on staff to assist with fires.
- -30 staff in different processes of training, maintaining social distancing.
- 9 fully trained crew members actively ready to assist Mishkeegogamang.
- -Small grass firee in Mish, was resolved by Mish Fire Rescue.

3.5 Nurse Johnson

- -N95 masks donated by Councillor Walbourne greatly appreciated.
- -No major changes, some PPE still backordered.
- -test results still going to Toronto with a 8-10 day turn around.

- PPE in good supply, awaiting tear off coverall resupply.
- -All closure notices in place and functioning.
- 3.7 Clerk Treasurer Jamie Hussey
- 247 Municipal Declarations, 70 FN.
- -Province rolled out reopening plan for some businesses today, shared via email.
- -Closures extended until May 12th. Municipality to follow suit.
- -No changes for any Municipal Funding.
- -Edo working with FEDNOR to roll out weekly funding updates on website.
