6.1 Mayor & Council

- **6.1.1 Councillor Blakney** Inquiry on if follow up of health services lists are being generated. Clerk and EDO established awaiting final reports from NCS and Council review before developing lists as study identifies specifics.
- -Inquiry if generating a list of contractors/plumbers/specialty trades for website can be achieved. Clerk and EDO agree excellent initiative and first project for EDO Intern.
- -Website updates, contract someone to build, update website and train staff on how to use. Estimated cost \$5,000.00-\$10,000.00 for website revamp and training.
- **6.1.2 Councillor Vaughan-** Inquired when the new road construction would begin. Clerk commented EA is wrapping up and once reviewed a 30 day appeals period will take place.

- -Asked superintendent to get in contact with MTO, the highway sign coming into town that MTO put up is not in the Municipal boundary.
- -Asked clerk to get an agreement in writing about the corner of Highway 599 and Pickle Lake for sign development with Rose Koval.
- -Asked clerk to get agreement in writing for use of Open space on lakeview crescent from Mercedes Hopf before playground is installed as transfer to Township will not take place until a later date.
- -Highway sign designs, run a photo contest, short catchy phrase for new signs, include township website address.
- -Dr. Mooney will be coming over another long weekend, to maximize on the benefits the province pays for his trip here Clerk to ask to extend his trip one day for full 10 days of locum coverage.
- -Mayor Monck will call MP Melillo to see how things are coming on the federal side for the Water Tower grant.
- -Council further discussed as a group free rental for the Inclusivaction Paddle days and having someone available with the keys on these days.
- -Naming of new playground, confirm with Mercedes what they would like to have on the plaque.
