3. DELEGATIONS

Sgt Katherine Ross of the Municipal Policing Bureau presented on OPP billing. The presentation was in PowerPoint form and allowed for questions from the board. The Presentation was 1 hour in length.

Sgt. Ross left the meeting at 14:15 p.m.

Insp. Duewel presented the Q1 2021 report to the board. There was a few questions concerning diminished lockups and hours which corelate with the stay at home order from COVID-19. OPP is seeing fewer calls for service.

Board Member Rasmussen inquired about children welfare checks and what level of involvement OPP has in regards to children not attending school. Sgt. Porritt referred to Children's Aid, however, is willing to co-ordinate to assist where possible for these issues.

Mayor Monck inquired about stepping up patrol in known party areas around town, especially during the stay at home order. Sgt. Martin will follow up with constables.

Sgt. Martin and Porritt commented on ability to mobilize community members that are high risk to treatment in other communities. More flagging of prisoners will take place to ensure these high-risk individuals are identified for treatment programs.

Insp. Duewel reported on ask of Federal Crown to direct all collected monies from drug trafficking to local shelters, women's crisis, victim services. Board in agreement this is a positive step forward. Recommended that board drafts letter supporting this endeavour. Insp. Duewel is also working to collaborate a better online presence for Sioux and Pickle detachments. OPP work with municipality to have a direct portal through website, along with updated Facebook posts and detachment descriptions/photos.

Mayor Monck discussed the potential new detachment board format. Meeting with Sioux Lookout on Monday, May 3rd to discuss potential amalgamation.

Inspector Duewel commented on their current reporting requirements for Wapakeka and Weagamow FN.
