BY-LAW NO. 2022-07

## BEING A BY LAW TO OPEN AND ESTABLISH A PUBLIC ROAD OF THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE WITH THE NAME AIRPORT ROAD

**WHEREAS** it is advisable and expedient to open up and establish the hereinafter referred to Lands as a public access road of the Corporation of the Township of Pickle Lake:


**AND WHEREAS** the consent of the Minister of Transportation ("the Minister") to such opening is required pursuant to Subsection 24(3) of the Public Transportation and Highway Improvement Act R.S.O 1990, c. 50;

**NOW THEREFORE** the Council of the Corporation of the Township of Pickle Lake enacts as follows:

1. That the following lands namely adjacent to Pickle Lake Airport, 3.1 HA, as described in attached LUP provided by Ministry of Natural Resources. Location Co-ordinates: 51.448683 N, -90.203440W extending to 51.448523N, -90.180867W. The lands extend from known lands of File MNR 188561 RP 23r3695 Part 2 to 11 PT Parts 1 and 12.
2. This By-law shall come into force and take effect at this time of passing and when the consent of the Minister is endorsed hereon pursuant to Subsection 24(3) of the Public Transportation and Highway Improvement Act. This will be in effect on the current Land Use Permit SL-2021-PLA-00060-LUP-001, and thereafter once the land is registered with the Land Registry Office for the District of Kenora has been completed.
3. The road shall be named Airport Road.
