BY-LAW NO. 2022-08



BEING A BY LAW TO OPEN AND ESTABLISH A PUBLIC ROAD OF THE CORPORATION OF THE TOWNSHIP OF PICKLE LAKE WITH THE NAME PICKLE CROW ROAD

WHEREAS it is advisable and expedient to open up and establish the hereinafter referred to Lands as a public access road of the Corporation of the Township of Pickle Lake:

AND WHEREAS the consent of the Minister of Transportation (“the Minister”) to such opening is required pursuant to Subsection 24(3) of the Public Transportation and Highway Improvement Act R.S.O 1990, c. 50;

NOW THEREFORE the Council of the Corporation of the Township of Pickle Lake enacts as follows:

1. This By-law shall come into force and take effect at this time of passing and when the consent of the Minister is endorsed hereon pursuant to Subsection 24(3) of the Public Transportation and Highway Improvement Act, which has been registered with the Land Registry Office for the District of Kenora.
3. The Road shall be named Pickle Crow Road.

CONSENT OF THE MINISTER OF TRANSPORTATION
