6.1 Mayor & Council

6.1.1 Councillor Blakney

- July 1st Confirmed with staff if Fireworks had been procured for Canada Day –Clerk Treasurer confirmed order and delivery to the Town.

Council engaged in a discussion surrounding safe planning of the controlled burned which includes contacting fire department leadership, and ensuring there is adequate memberage and apparatus available for control of the scene. Councillor Vaughan as the CEMC will plan the exercise with Fire Department leadership and OPP and the Control Group for the Township of Pickle Lake to ensure the exercise is compliant to be used for a OFMEM annual full scale emergency training exercise for the Emergency Plan.
